

#### ΕΙΣΑΓΩΓΙΚΑ – ΣΧΟΛΙΑ<sup>2</sup>

- Η 5μερής Διάσκεψη για το Κυπριακό στη Γενεύη συνέρχεται τη στιγμή που η θέση της Τουρκίας αναβαθμίζεται: στη ΜΑ έχει αποκτήσει επιρροή στη Συρία και προστατεύει τους Παλαιστινίους σε βάρος των σχέσεών της με το Ισραήλ, στην Ουκρανία εμφανίζεται ως κατάλληλος μεσολαβητής με καλές σχέσεις τόσο με το Κίεβο όσο και με τη Μόσχα και στην Ευρώπη θεωρείται ως αναγκαίος εταίρος για τη νέα αρχιτεκτονική ασφαλείας που οικοδομείται λόγω της τάσεως των ΗΠΑ να «αποδεσμευτούν» από την άμυνα της Ευρώπης. Λόγω της στρατιωτικής της εμπειρίας, της πολιτικής της επιρροής και της ισχυρής πολεμικής της βιομηχανίας η Τουρκία θεωρεί ότι μπορεί να υπαγορεύσει στην Ευρώπη τους όρους συνεργασίας και να απαιτήσει «ανταλλάγματα». Θα φανεί, αν τα ανταλλάγματα αυτά θα είναι θεσμικού (συμμετοχή στη διαδικασία λήψεως αποφάσεων της ΕΕ για την εξωτερική πολιτική, την ασφάλεια και την άμυνα της ΕΕ) ή εμπορικού-οικονομικού χαρακτήρα ή θα επεκτείνονται και σε απόκτηση πυρηνικών όπλων ή σε αναδιατύπωση των όρων της Συνθήκης της Λωζάννης και χάραξη θαλασσίων ζωνών κατά παράβαση του ΔΔ σε βάρος της Ελλάδος και της επιδίωξης λύσης δύο κρατών στην Κύπρο.
- Η αλλαγή της πολιτικής ηγεσίας των ΗΠΑ και η προοπτική κατάπαυσης του πυρός, ανακωχής ή τερματισμού του πολέμου στην Ουκρανία φαίνεται ότι εξασθενίζουν τη γεωπολιτική και διπλωματική θέση της Ελλάδος (σε αντίθεση με την Τουρκία). Ορθώς η ελληνική και η κυπριακή αντιπροσωπεία επεσήμαναν σε πρόσφατη διεθνή συνάντηση ότι Ελλάδα και Κύπρος θα διαδραματίσουν σημαντικό ρόλο ως «σημεία υποδοχής» του θαλασσίου διαδρόμου Ινδίας-Σαουδικής Αραβίας-Ισραήλ-Κύπρου-Ελλάδος-Ευρώπης («India Middle East Corridor, IMEC»), ο οποίος θα είναι ανταγωνιστικός του κινεζικού χερσαίου «Δρόμου του Μεταξιού» («Road&Belt Corridor») που θα διέρχεται από το Πακιστάν και θα φτάνει στην Τουρκία. Επί των ελληνικών και κυπριακών απόψεων εκφράστηκε θετικά και ο Π/Τράμπ σε διαδικτυακή του ανάρτηση («Truth Social»).
- Οι αντιπροσωπείες των ΗΠΑ και της Ουκρανίας συναντήθηκαν στη Τζέντα για να συζητήσουν επί του αμερικανικού σχεδίου για την Ουκρανία. Η Ουκρανία απεδέχθη τη σύναψη συμφωνίας ανακωχής με τη Ρωσία και συμφωνίας με τις ΗΠΑ για τα ορυκτά. Το σχέδιο παρουσιάστηκα από την αμερικανική αντιπροσωπεία στον Π/Πούτιν στη Μόσχα. Η ρωσική απάντηση ήταν κατ΄ αρχήν θετική, αλλά ο ρ/Π υπογράμμισε ότι απαιτείται λύση που να άπτεται των αιτιών του πολέμου και να αποβλέπει σε μακροπρόθεσμη και όχι προσωρινή διευθέτηση του ζητήματος. Ειδικώτερα, η ρ/πλευρά επιδιώκει την υλοποίηση των όρων της συμφωνίας της Κωνσταντινούπολης («Istanbul plus»), τη διακοπή του στρατιωτικού ανεφοδιασμού του Κιέβου από την Ουάσιγκτον και την παράδοση των ουκρανικών στρατευμάτων

του ονόματός του.

- στην περιοχή Κουρσκ (είναι ήδη περικυκλωμένα από τις ρ/ΕΔ). Επί πλέον θέτει το ζήτημα της αναδιοργάνωσης των ουκ/ΕΔ κατά τη διάρκεια της ανακωχής.
- Στη Συρία έχει εκδηλωθεί εξέγερση των Αλαουιτών κατά του νέου σουνιτικού καθεστώτος, με αποτέλεσμα αστάθεια και έξαρση της βίας, διώξεις και σφαγές κατ΄ αμάχων. Το καθεστώς φαίνεται ότι αναζητεί τρόπο συνεννόησης με την κουρδική μειονότητα.
- Στις διαπραγματεύσεις της Ντόχα, η αντιπροσωπεία των ΗΠΑ έδειξε ότι εγκαταλείπει την ακραία πρόταση για εθνική κάθαρση των Παλαιστινίων και ότι τείνει να αποδεχτεί το αραβικό σχέδιο ανοικοδόμησης της Γάζα. Περαιτέρω, η αμερικανική πλευρά προτείνει νέα ανακωχή διαρκείας 50 ημερών, ανταλλαγή κρατουμένων και ομήρων και αναζήτηση τελικής λύσης. Ενδιαφέρουσα η διαφαινομένη προσέγγιση ΗΠΑ-Παλαιστινιακής Αρχής.
- Το Ιράν υποστηριζόμενο από Ρωσία και Κίνα δείχνει διατεθειμένο να συζητήσει το πυρηνικό του πρόγραμμα.

Mediterranean Leaders Excited for Possibilities of Peace, Economic Agreements with Trump's Return

(17/02/2025)

Papadopoulou also discussed the economic opportunities in the region, specifically the possibility of establishing the India-Middle East—Europe (IMEC) corridor. The proposed trade route would run from India through the Middle East into Europe and America, mirroring China's Belt and Road initiative.

Papadopoulou called it "an opportunity to be taken advantage of."

"When you see the map, the map speaks by itself. You have the land, and you have the sea," she explained. "And if you see the Belt and Road, it's China, through Central Asia, through Pakistan, and then all the way to Turkey. But this is taken; it's taken by China, and it's natural because it's Russia, China, you don't have anything, no chance there. But there is the maritime corridor, and it's the South China Sea, India and the Gulf countries, Saudi Arabia, Israel, Cyprus, Greece, and then all the way to Europe, and then eventually the U.S.."

She emphasized that "all the dots are there" to create a "maritime" corridor, and Greece and Cyprus could "serve as the glue" for the trade route.

"So it's obvious that for all of us, the maritime road is one-way street. There is no other choice," she said. "The foundation for this corridor is there. It's the "3+1", which is Cyprus, Israel, Greece, plus the U.S.—the system. Then you have the strategic relationship between Greece and Israel, the strategic relationship between Greece and India, then the excellent relations, more than excellent relations, with Saudi Arabia and Egypt. So all the dots are there, and Greece and Cyprus can serve as the glue that brings that part of the world connected to the European Union through a corridor that provides political stability, economic openness because this is free market—we're members of the European Union—and very strong alliance with the United States. So you have all the elements in place."

# The SDF-Damascus agreement for Ankara could help achieve some domestic and foreign goals

"President Erdogan's primary objectives in Syria are to establish a reliable partner for Türkiye in trade, energy, and defence, enable the return of millions of Syrian refugees, and dismantle the PKK-linked Kurdish autonomous region. Ankara sees the recent agreement between Damascus and the Syrian Democratic Forces (SDF) as a step toward achieving these goals. For Syrian leader Ahmed al-Sharaa, the deal is a way to demonstrate stability and reassure the West of his commitment to protecting minorities. This could help him secure Western support, which Türkiye also hopes to leverage for Syria's reconstruction, as Ankara lacks the financial resources to lead rebuilding efforts

alone. If the agreement leads to the dissolution of Kurdish autonomy, Erdogan could claim a major political victory ahead of the 2028 elections. The deal also opens the door for integrating Kurdish forces into the Syrian national army, which may pave the way for a US troop withdrawal – removing a key friction point in Turkish-American relations. The agreement could also undercut Israel and Iran, both of whom have used Kurdish groups to counter Türkiye's influence in Syria."

"The entire idea of Christian civilisation that led to the founding of the United States of America was formed in Europe. The cultural bonds, the religious bonds – these things are going to last beyond political disagreements," Vance said.

"But I think that Europe, and frankly, I would have said this about America a year ago, is at risk, I think, of engaging in civilizational suicide."

Vance particularly highlighted the open borders agenda that has come to dominate much of Europe over the past decade and the increasingly authoritarian speech restrictions imposed by supposedly liberal governments in the EU and UK.

Not only the French, but also British nuclear forces are geared strongly towards national defense. The United Kingdom is the only nuclear-armed state with only one type of nuclear weapon. The country's nuclear deterrent is entirely sea-based. It is made up of four nuclear submarines stationed on the west coast of Scotland.

What is conceivable is a stronger strategic partnership or a "political declaration that the French and British nuclear arsenal would also be used to defend European territory in an emergency," security expert Sascha Hach told DW. "But I think it's unrealistic to expect the nuclear forces in France and the UK to develop in such a way that they would be tailored to European defense."

The number of nuclear bombs is not the decisive factor, according to Hach. He warned that other important defense measures might also disappear without the US, such as direct military relations with the other side. "I would say that it is in Europe's interest to set up similar structures and mechanisms that will give us control."

"Putin's position today rejects an unconditional cease-fire -- an uncomfortable stance that risks angering Trump and hindering the otherwise promising prospects of normalizing bilateral relations," Tatyana Stanovaya, a veteran Russian political analyst, wrote in a post to X.

"However, this rejection is not absolute; he outlines his demands. His key condition is that a cease-fire must serve as a stepping stone to substantive talks on the root causes of the conflict -- Ukraine must agree to discuss an 'Istanbul Plus' framework, which Russia views as a path to Kyiv's capitulation," she wrote.

"Istanbul Plus" is a reference to the 2022 negotiations that Russia and Ukraine held in the few weeks after the beginning of the all-out invasion, in February 2022. The negotiations led a framework agreement that observers say would have amounted to all-out capitulation by Ukraine.

"Putin also requires commitments from the US to halt military supplies, while Kyiv must pledge not to fortify its defense lines or use the pause for rearmament. Zelensky's legitimacy must also be addressed," she wrote, referring to recurring Kremlin assertions that the Ukrainian leader lacks legitimacy because martial law has prevented Ukraine from holding new elections.



Ukrainian Air Force Laments F-16s Can't Compete with Russian Su-35s (11/03/25)

Seven months after the deliveries of the first F-16 fourth generation fighters to Ukraine, Ukrainian Air Force spokesperson Yuri Ignat provided insight into the fighters' capabilities, stating that they were incapable of engaging the <u>Su-35 '4+ generation'</u> fighters in the Russian Air Force. "The modifications that Ukraine has cannot compete

one-on-one in an air battle. We need a comprehensive approach as the [Russian] Su-35 is a relatively new jet... This includes ground-based air defence, electronic warfare systems, and ideally, an airborne radar. Also crucial are onboard radars for our aircraft and air-to-air missiles," he observed. The capabilities of F-16s supplied to Ukraine have repeatedly been brought to question, with the aircraft being supplied second hand by Belgium, Denmark, the Netherlands, and Norway which received very early models in the 1980s. These fighters not only rely on obsolete mechanically scanned array radars, but also lack the Link 16 data link system which leaves their ability to operate as part of a network with other assets highly limited.

Ukraine's ATACMS Missile Stockpiles Have Run Dry: A Major Blow to the War Effort (13/03/25)

The Ukrainian Army has expended its supply of American supplied Army Tactical Missile System (ATACMS) missiles during hostilities with Russia, according to a report by a U.S. official to the Associated Press. Ukraine's stock of ATACMS was fully exhausted by late January, while the country has recently received "fewer than 40" new missiles to replenish them. ATACMS were supplied to Ukraine from September 2023, and have proven particularly effective for precision strikes on high value Russian targets. In January they were used to launch a <u>successful strike</u> on an 92N6 detection radar from a <u>Russian S-400</u> long range surface to air missile system near the frontlines near the city of Belgorod, and two months prior were <u>used to destroy</u> two launchers from another S-400 system. Attacks using the systems <u>escalated from November 17</u>, after Washington <u>provided the green light</u> for use of the missiles against internationally

recognised Russian territory. ATACMS missiles require use of <u>Western satellite</u> <u>networks</u> for targeting, as well as the <u>extensive presences</u> of supporting active duty and contractor personnel from Western countries. American Global Hawk surveillance drones flying near Russia are also reported to have <u>provided key support</u> allowing the missiles to be effectively utilised.

Belarus Producing Launchers For New Oreshnik Intermediate Range Ballistic Missiles (14/03/25)

Belarussian President Aleksandr Lukashenko has confirmed that his country has initiated manufacturing of several launchers for the Russian Oreshnik intermediate range ballistic missile system, adding that these were nearing completion. He noted that Belarus would require the missiles produced in Russia to complete the systems, and that the placement of the Oreshnik system in Belarus was progressing in accordance with bilateral agreements. It remains uncertain whether Belarusian firms are producing launchers exclusively for Oreshnik launchers that will be deployed in the country, or whether they are also supplying the Russian Armed Forces, with the latter option appearing more likely. Belarus has a long history of producing advanced missile launch vehicles, with the Minsk Automobile Plant (MAZ) having developed several transporter erector launcher systems including the MAZ-547A launcher used for the Oreshnik's predecessor the RSD-10 intermediate range ballistic missile.

Although the Israeli delegation sent to Doha has limited powers to negotiate, the resumption of talks after a tense week of Israeli threats can be seen as a change in the U.S. position, which moved from Trump's provocative proposal to ethnically cleanse Palestinians from Gaza and build a "Riviera" in their place to discussing terms directly with Hamas and presenting consecutive proposals to move on to talks over ending the war.

At the heart of this change is the issue of Gaza's reconstruction and the <u>Arab Summit counter-proposal</u> in early March. On Wednesday, the meeting of Arab foreign ministers in Doha presented the plan to Witkoff and agreed to discuss it in ongoing talks as "a basis for reconstruction efforts in the strip," according to various <u>Arab media reports</u>.

While Palestinians in Gaza and the families of Israeli captives place their hopes in the renewed round of talks in Doha — and now, the prospect of advancing talks over the second phase of the ceasefire following Hamas's announcement on Friday — the prospects for reaching a final agreement remain remote. Netanyahu's government shows no sign of being willing to end the war. He will now attempt to find a way of avoiding moving forward in the negotiating process and find a way to pin the blame on Hamas, as he has done numerous times in the past.

The interim government has disrupted this smuggling activity, depriving those Sunni Arab militiamen of a critical revenue stream.[iv] Though the insurgency in the Alawite-majority coast and the nascent insurgent cells in the Sunni-majority Euphrates region are currently distinct and motivated differently, they could coalesce into a broader coalition in time, which would seriously threaten the Syrian interim government.



Following the overthrow of the Syrian government by Turkish-backed jihadist insurgents, a continuous spate of attacks on Syria's ethnic and religious minorities by Al Oaeda affiliated Sunni radicals has escalated into massacres of entire Shiite population centres in the Latakia governate. After weeks of mass protests by the Shiite community against brutalisation by the new Islamist authorities, the taking up of arms by former

military personnel in Latakia has been met with an overwhelming response, with footage showing heavily armed jihadist paramilitaries rolling into the governate in large numbers to restore their authority. Turkish special and regular forces have been reported to also be deploying to support these offensives, with footage from multiple sources confirming door to door massacres of Shiite civilians. This follows months of footage confirming killings, public humiliations and mass rapes by the <u>Turkish backed</u> Islamists. With many of the jihadists being former members or affiliates of the Islamic State terror group, including their leader self-appointed President Abu Muhammad Al Julani, conduct towards the Shiite population has born strong parallels to the massacres, <u>mass rapes and enslavement</u> of the Yazidi minority by Islamic State in Iraq.

China earlier this week concluded its Two Sessions conclave, the annual parallel meetings of the National People's Congress (NPC) and Chinese People's Political Consultative Conference (CPPCC). As usual, the country's Premier, currently Li Qiang, issued the opening speech summarizing the Government Work Report (GWR), the government's most authoritative summary of their performance for the previous year and their policy goals and plans for 2025. The overall agenda also included discussion of reports on the state of the economy and development, central and local government budgets, and reports from the NPC Standing Committee, Supreme People's Court, and Supreme People's Procuratorate. Several officials, including Foreign Minister and Director of the Chinese Communist Party Central Committee Foreign Affairs Commission Wang Yi, held press conferences, though this was the second year in a row that the Premier did not hold a press briefing at the conclusion of the meetings. The actual legislative agenda was modest, with only revisions made to the law on NPC deputies. 

Trump's tariffs and the illusion of de-globalization

Trump's protectionism ultimately about getting US big business a better deal, not the dismantling of free-trade driven globalization

While the growth experienced since 1970 ground to a halt, the index's indicators disprove any claim that globalization receded during Trump's first term in office.

This second term may well be different because, according to some experts, the president has learned to bypass political counterweights, to surround himself with likeminded people, and to free himself from partisan ties in order to implement his own agenda.

Others, however, question the very existence of his own agenda beyond the interests of big business, because it is precisely this alignment of interests that allows him to:

- Impose <u>tariffs on developed countries</u>, and on products competing for the same markets.
- Make political use of tariffs to threaten other countries and <u>secure access to vital</u> <u>resources</u> for the technology race (mainly due to the US' position of being the world's largest buyer and military power).
- Launch a new arms race that will boost the profits of US industry.
- Use a nationalist and anti-globalization narrative to justify the growing precariousness of the US working class. He aims to unite US citizens behind the flag, dilute their class consciousness, and offer up new scapegoats in the form of immigrants.

In reality, Trump's agenda is unlikely to be compatible with any meaningful deglobalization process. Reversing globalization would be contrary to the interests of US capital, which needs to expand – into both new territories and sectors – to ensure its own survival.

In light of all this, why would US multinationals want to stop making huge profits in other countries? What could lead them to give up producing in territories with lower production costs, cheaper labor and a guaranteed supply of raw materials?
